<u>H.Res. 693</u> – Rule providing for consideration of both H.R. 3326 – World Bank Accountability Act of 2017 (Rep. Barr – Financial Services) and <u>H.R. 2954</u> – Home Mortgage Disclosure Adjustment Act (Rep. Emmer – Financial Services) (One hour of debate). The Rules Committee has recommended one Rule which would provide for consideration of two bills.

For H.R. 3326, the Rules Committee has recommended a structured Rule that provides for one hour of general debate equally divided and controlled by the Chair and Ranking Member of the Committee on Financial Services. The Rule provides for consideration of 3 amendments, each debatable for 10 minutes, equally controlled by the proponent and opponent of the amendment. The Rule allows one motion to recommit, with or without instructions, and waives all points of order against the legislation.

For H.R. 2954, the Rules Committee has recommended a closed Rule that provides for one hour of general debate equally divided and controlled by the Chair and Ranking Member of the Committee on Financial Services. The Rule allows one motion to recommit, with or without instructions, and waives all points of order against the legislation.

The Rules Committee blocked two germane amendments, including one by Rep. Moore of Wisconsin that would have improved H.R. 3326. **Members are urged to <u>VOTE NO</u>**.

<u>H.R. 3326</u> – World Bank Accountability Act of 2017 (Rep. Barr – Financial Services) (One hour of debate). While this bill authorizes \$3.29 billion for the U.S. contribution to the World Bank's International Development Association (IDA) for FY 2018 – FY 2020, it withholds up to 30% of the funding unless certain requirements are met. While most of the requirements are reasonable, withholding funds that benefit the poorest countries in the world is not the appropriate way of pushing the Bank to reform its operations.

When H.R. 3326 was being considered in Committee, Ranking Member Waters urged support for the bill with the understanding that Chairman Hensarling and his staff would continue to work on components that Democrats opposed. Despite that agreement, House Republicans decided to move the bill to the Floor without changes. In another attempt to improve the bill, Rep. Moore (WI) offered an amendment that would have allowed the Secretary of the Treasury to voice U.S. concerns at the bank, instead of enforcing overreaching and vague policy reforms through cuts to funding that will hurt some of the poorest people in the world, but her amendment was not made in order.

On several occasions Democrats attempted to work with Republicans to improve this legislation that impacts the most vulnerable in the world, but Republicans decided to move forward on their own. For these reasons, **Members are urged to <u>VOTE NO</u>**.

The Rule provides for one hour of general debate and makes in order 3 amendments, debatable for 10 minutes, equally divided between the offeror and an opponent. The amendments are:

Norman Amendment. Modifies a Treasury reporting requirement to ensure that the World Bank is promoting reduction of government barriers to entrepreneurship as an important component of poverty reduction.

Connolly Amendment. Requires a report on steps taken by the World Bank to ensure G-5 visa holders (foreign domestic workers) employed by World Bank diplomats and staff are informed of the protections afforded to them pursuant to the William Wilberforce Trafficking Victims Protection Reauthorization Act.

Barr Amendment. Mandates that the U.S. oppose IDA assistance (other than assistance for basic human needs) to a foreign government if the foreign government knowingly fails to enforce UN Security Council sanctions against North Korea. The amendment includes Presidential waiver authority.
