<u>H.J.Res. 100</u> – To provide for a resolution with respect to the unresolved disputes between certain railroads represented by the National Carriers' Conference Committee of the National Railway Labor Conference and certain of their employees (Rep. Payne – Transportation and Infrastructure)

The Rule will provide for one hour of debate equally divided and controlled by the Chair and Ranking Member of the Committee on Transportation and Infrastructure.

<u>H.Con.Res. 119</u> – Providing for a correction in the enrollment of H.J. Res. 100 (Rep. DeFazio – Transportation and Infrastructure)

The Rule will provide for ten minutes of debate equally divided and controlled by the Chair and Ranking Member of the Committee on Transportation and Infrastructure.
