TOMORROW’S OUTLOOK

The GOP Leadership has announced the following schedule for Wednesday, April 25: On Wednesday, the House will meet at 9:00 a.m. and recess immediately. The House will reconvene at approximately 10:30 a.m. for the purpose of receiving, in a Joint Meeting with the Senate, His Excellency Emmanuel Macron, President of the Republic of France. **Members are advised to be on the House Floor and seated no later than 10:05 a.m. for the Joint Meeting.**

The House is expected to consider [H.R. 3144](#) – To provide for operations of the Federal Columbia River Power System pursuant to a certain operation plan for a specified period of time, and for other purposes (Rep. McMorris Rodgers – Natural Resources) (Subject to a Rule). The House is also expected to begin consideration of [H.R. 4](#) – FAA Reauthorization Act of 2018 (Rep. Shuster – Transportation and Infrastructure) (Subject to a Rule). Lastly, the House will consider [H.R. 5447](#) – Music Modernization Act, as amended (Rep. Goodlatte – Judiciary) – under suspension of the Rules.
