<u>H.Res. 1011</u> – Rule providing for consideration of H.R. 184 – Protect Medical Innovation Act of 2017 (Rep. The Rules Committee has recommended one Rule which would provide for consideration of two bills.

For <u>H.R. 184</u>, the Rules Committee has recommended a closed Rule that provides for one hour of general debate on the motion equally divided and controlled by the Chair and Ranking Member of the Committee on Ways and Means. The Rule allows one motion to recommit, with or without instructions, and waives all points of order against the legislation.

For <u>H.R. 6311</u>, the Rules Committee has recommended a closed Rule that provides for one hour of general debate on the motion equally divided and controlled by the Chair and Ranking Member of the Committee on Ways and Means. The Rule allows one motion to recommit, with or without instructions, and waives all points of order against the legislation. **Members are urged to <u>VOTE NO</u>**.

<u>H.Res. 1012</u> – Rule providing for consideration of <u>H.R. 6199</u> – Restoring Access to Medication and Modernizing Health Savings Accounts Act of 2018 (Rep. Jenkins – Ways and Means) (One hour of debate). The Rules Committee has recommended a closed Rule that provides for one hour of general debate on the motion equally divided and controlled by the Chair and Ranking Member of the Committee on Ways and Means. The Rule allows one motion to recommit, with or without instructions, and waives all points of order against the legislation.

The Rules Committee rejected a motion by Mr. Hastings of Florida to make in order and provide the appropriate waivers to amendment #1, offered by Reps. Duncan and DesJarlais of Tennessee which expands deductible medical expenses to include dietary supplements, such as over-the-counter vitamins, minerals, herbs, and fiber. **Members are urged to <u>VOTE NO</u>**.

<u>H.R. 184</u> – Protect Medical Innovation Act of 2018 (Rep. Paulsen – Ways and Means) (One Hour of Debate). This bill would repeal, without offset, the excise tax established by the ACA on medical devices manufactured in the U.S. or imported going forward.

Because most sectors of the health industry were correctly expected to benefit from additional revenue when millions of previously uninsured Americans gained coverage under the ACA, the ACA included a series of provisions that asked those industries that are benefitting to contribute a portion of their additional revenue to help pay for the newly insured. These provisions helped to ensure that the ACA reduces the deficit, as confirmed time and again by the Congressional Budget Office. In the case of the medical devices, this contribution comes in the form of a 2.3% excise tax on revenues from all devices sold in the United States.

This permanent tax cut will add billions to the deficit, and Republicans have chosen to bring the bill to the Floor without providing an offset just a few months after House Republican's \$1.8 trillion deficit exploding tax cuts that benefit the wealthiest people in our nation.

It is clear that this fiscally irresponsible bill is just another Republican attempt to undermine the ACA. Skyrocketing health care costs are bleeding American families dry at the same time Republicans and Donald Trump continue their political attacks on the ACA. House Republicans should work with Democrats to help improve the lives of the American people instead of forcing them to suffer the consequences of their irresponsible, politically driven actions.
