<u>H.Res. 348</u> – Rule providing for consideration of <u>H.R. 953</u> – Reducing Regulatory Burdens Act of 2017 (Rep. Gibbs – Transportation and Infrastructure) (One hour of debate). The Rules Committee has recommended a structured Rule that provides for one hour of general debate equally divided and controlled by the Chair and Ranking Member of the Committee on Transportation and Infrastructure. The Rule provides for consideration of 2 amendments, debatable for 10 minutes, equally controlled by the proponent and opponent of the amendment. The Rule allows one motion to recommit, with or without instructions, and waives all points of order against the legislation. **Members are urged to <u>VOTE NO</u>**.
